Applicant agrees to:

- * Follow all rules and regulations for the Plano Mayor's Summer Internship Program.
- * Allow the, VWait Group, LLC, Plano ISD, City of Plano ("City") or ("Plano") and Capital One to use the applicant's photo, likeness, words, and name in any promotional materials for the Program.
